## Pet Transportation ("Pet Taxi") Release/Waiver of Liability

FurEver Furry Pet Care Services, LLC ("FurEver Furry") agrees to provide all pet care services in a reliable, caring, respectful and trustworthy manner. I, the Client ("Client"), understand that it is FurEver Furry's sole responsibility, with regard to my pet(s) to act with reasonable care. If my pet becomes ill, injured, dies and/or escapes while in the custody and care of FurEver Furry (whether such illness, injury or death is discovered while in the custody of FurEver Furry or afterwards), I agree that if FurEver Furry acted with reasonable care, I shall not bring any claim, suit, or action of any kind against FurEver Furry, the owners, their employees or affiliates arising out of the illness, injury or death of my pet(s).

I understand that there are inherent dangers in the transport of animals that are beyond the control of FurEver Furry, and therefore I release FurEver Furry, the owners, their employees or affiliates, from any liability in the event of my pet's injury or death during transport. In the event of an emergency (e.g., injured pets, severe weather, natural disasters, etc.), FurEver Furry is hereby authorized to take all measures deemed necessary in its sole and absolute discretion in caring for my pet(s) (including without limitation emergency veterinary care). In the event of such an emergency, I shall immediately reimburse FurEver Furry for expenses incurred, plus any additional fees or expenses for attending to such an emergency.

I understand that in any event that results in my pet(s) death (whether before, during or after seeking emergency veterinary care), FurEver Furry will contact me at the phone number I have provided. If I can not be reached immediately and I do not return any phone calls in a prompt manner, I understand that FurEver Furry will attempt to reach my Emergency Contact. If neither myself or my Emergency Contact can be reached, FurEver Furry will leave my pet with the veterinary staff and will no longer have control over the care of my pet(s). FurEver Furry agrees to notify me of the name, phone number and location of the veterinarian and I understand that my name, number and address may be shared with the staff as well.

I understand that I am responsible for making arrangements for my pet to be received at or retrieved from the designated facility. Furthermore, I will not hold FurEver Furry responsible for actions of the designated facility.

I understand that I am responsible for any and all payments due to the designated facility. In any instance, FurEver Furry is not responsible for my payments due. Furthermore, I understand that this may cause FurEver Furry to return my pet(s) to me or my home if the facility will not take possession.

I understand I must be available by phone for consultation while my pet(s) is with FurEver Furry.

I understand that FurEver Furry may be required to provide the pet facility with my personal contact information, including name, home address, and personal telephone numbers. I authorize FurEver Furry to provide such information to the pet service facility.

I understand that payment for pet taxi services is due prior to or upon pick up of my pet(s) and I agree to pay for any and all charges incurred by the transportation of my pet(s). I further understand that I will be billed for any additional fees incurred, including but not limited to an extended waiting period time, payment for which will be due upon receipt.

I certify that my pet(s) are currently vaccinated in accordance with all local and state laws and regulations. I agree to indemnify, defend and hold harmless FurEver Furry, its respective owners, employees, members, agents and affiliates from all liabilities, claims and expenses, including reasonable attorney's fees, that arise from or relate to my pet(s) behavior, including without limitation property damage, personal injury or death caused by my pet(s).

Either party may terminate this Agreement at any time for any reason or no reason by providing the other party with notice of such termination.

I certify that I have read, understand and agree to the rules and regulations set forth. I agree to abide by the rules and regulations and accept all terms, conditions and statements of this agreement.
