## Client Grooming Agreement & Waiver

**Current Vaccinations/Veterinarian Information:** By signing this contract, owners verify their pets are up to date on Rabies, Distemper and Bordetella.

**Aggressive or Dangerous Pets:** Owners MUST inform FurEver Furry if your pet(s) bite(s), has bitten, or is aggressive to people, other pets or specific grooming procedures. Muzzles may be used if necessary. FurEver Furry reserves the right to refuse/stop services for such pet(s) at any time before or during the grooming process.

**Health or Medical Problems & Senior Pets:** Grooming procedures can sometimes be stressful, especially for a senior pet or pets with health problems, and can expose hidden medical problems or aggravate a current one during or after the groom. Because senior pets and pets with health problems have a greater chance of injury, these pets will be groomed for cleanliness and comfort, in styles that will not add to their stress.

**Mat Removal:** Pets with matted coats need extra attention during their grooming session. FurEver Furry does not wish to cause undue stress to your pet, and will not continually de-mat the pet for you. Mats can be very difficult to remove, and may require the pet to be shaved. When necessary, removing a heavily matted coat includes risks of nicks, cuts or abrasions due to warts, moles or skin folds trapped in the mats. After-effects of mat removal procedures can include itchiness, skin redness, self-inflicted irritations or abrasions and failure of the hair to re-grow. In some cases pets may also exhibit brief behavioral changes.

**Accidents:** There is always the possibility that an accident could occur. Grooming equipment is sharp, even though we use extreme caution and care in all situations, possible problems could occur including cuts, nicks, scratches, quicking of nails, etc. In most cases this can happen when a pet is wiggling or moving around.

**Parasites:** If fleas or ticks are found during the grooming process, your pet will be treated with a mild product that has been manufactured for the purpose of removing the parasites and you will be charged for it. We can not guarantee the effectiveness of the product for all cases and recommend you consult a veterinarian for further treatment. Please note – FurEver Furry will not use pesticide dips or sprays on your pet. Ticks found will be removed for an additional charge.

**Hold Harmless Agreement**: By signing this contract you agree to hold FurEver Furry Pet Care Services, LLC, it's owners, operators, groomers and employees harmless from any damage, loss, or claim arising from any condition of the undersigned pet, either known or unknown to FurEver Furry. It is also further understood and agreed to that the terms of this agreement can change at any time, without notice, and will overwrite any and all prior signed contracts or releases. It is further understood this clause applies to any and all pets groomed.
